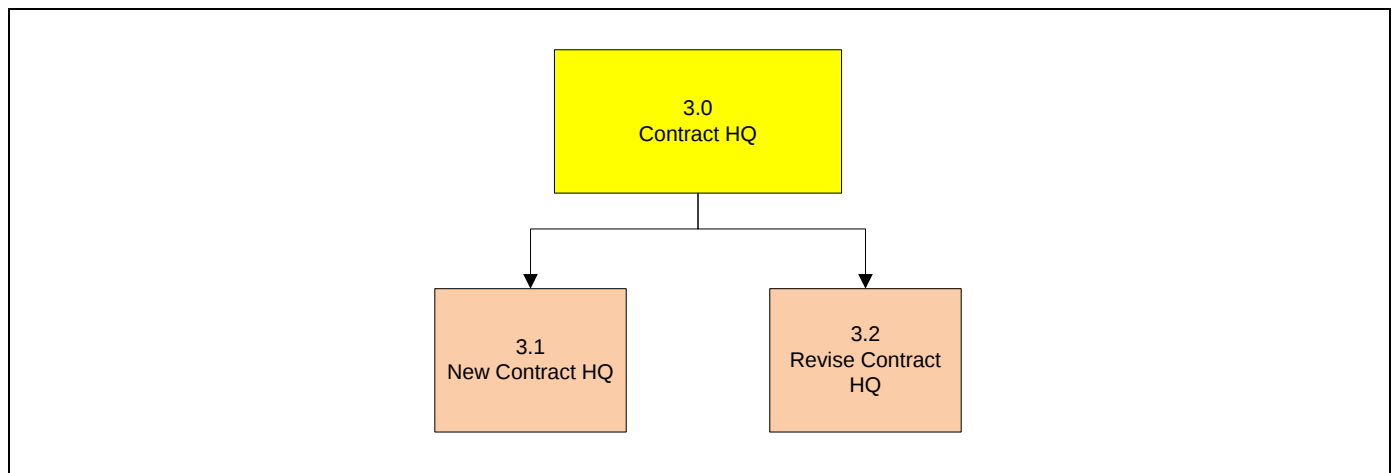

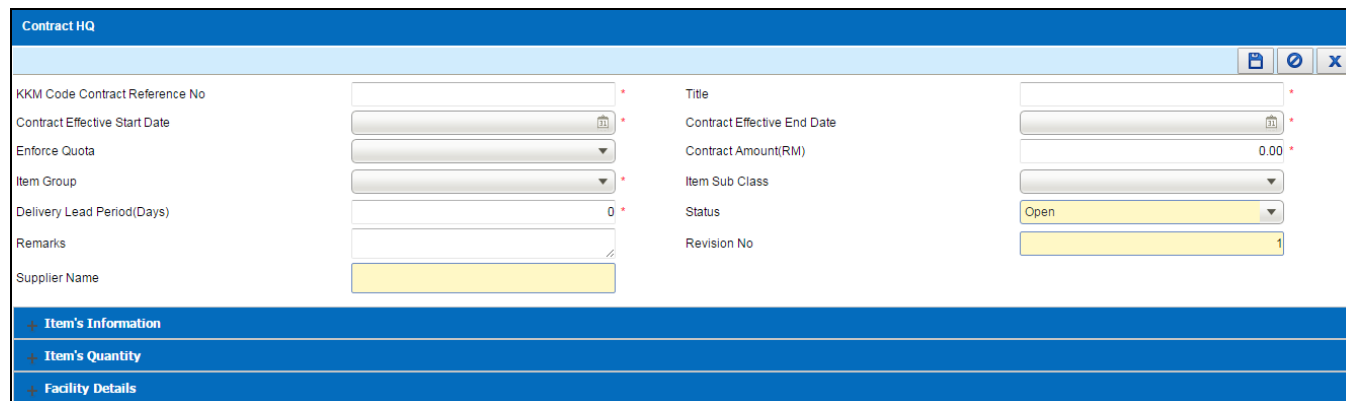
Figure 3.1.1-1 Create New Contract HQ

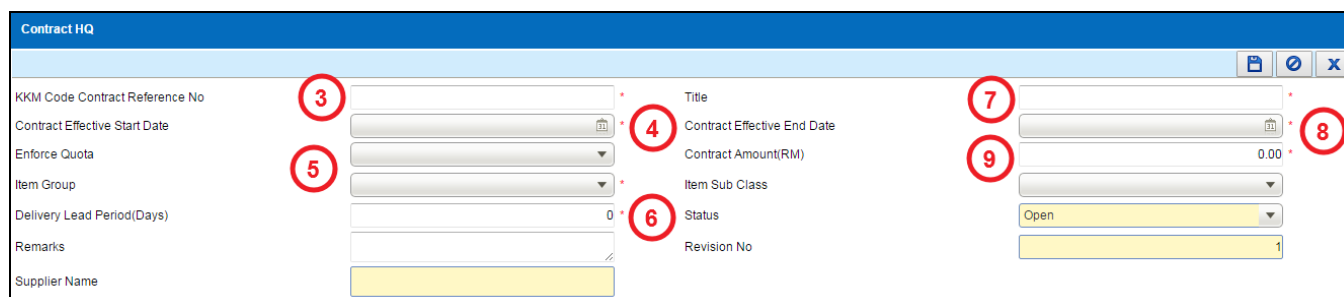

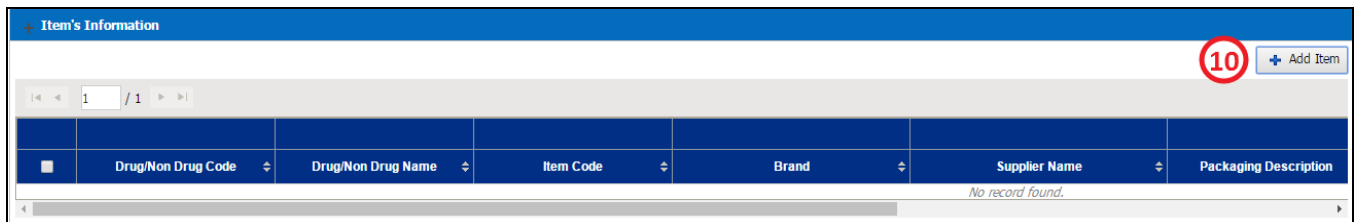
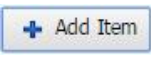


Figure 3.1.1-4 Item's Information

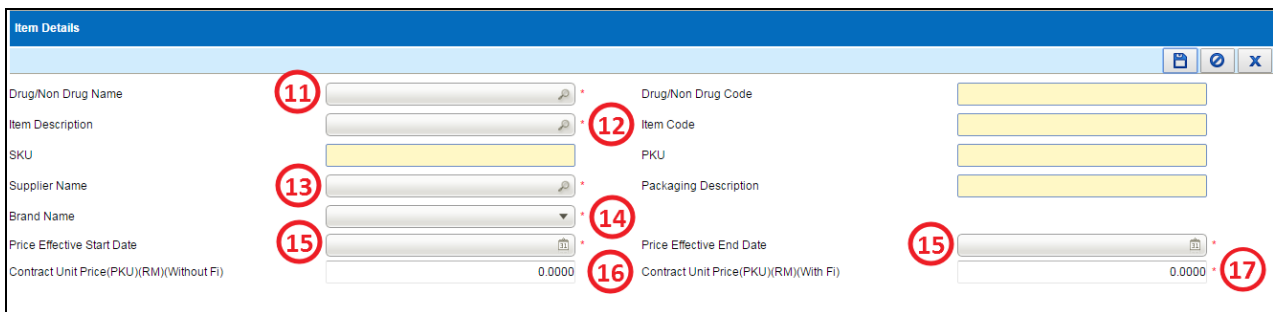


Figure 3.1.1-5 Item Detail

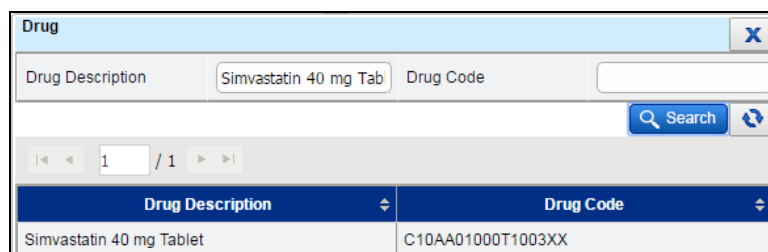


Figure 3.1.1-6 Drug List

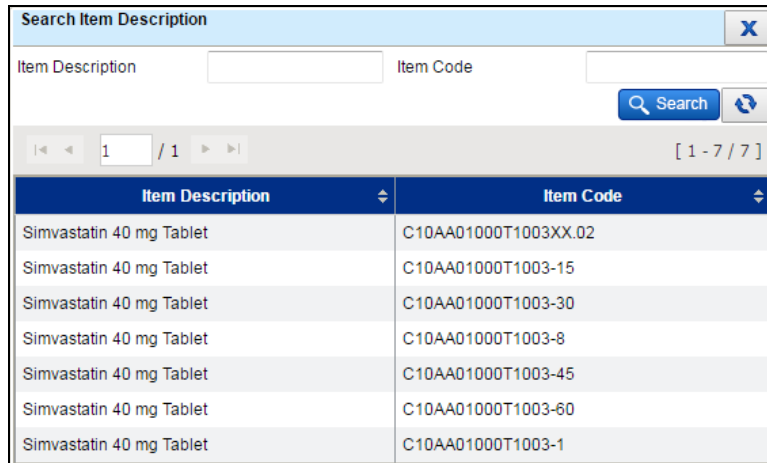

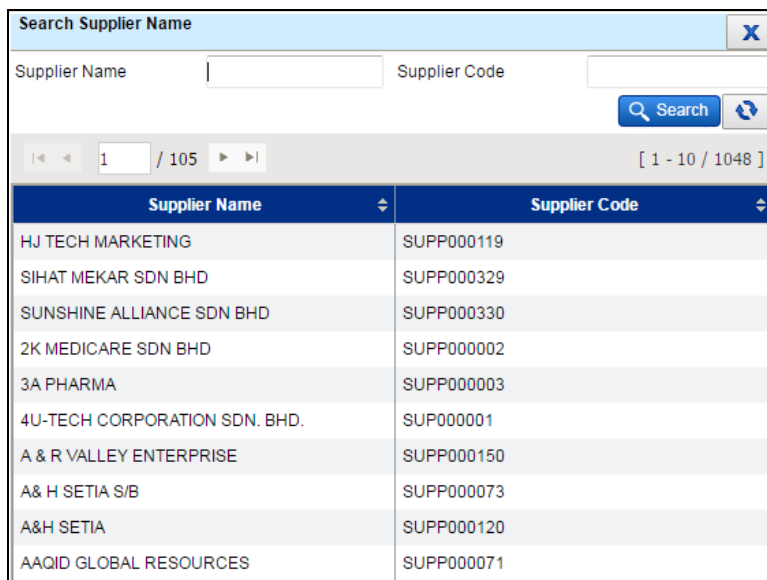
Figure 3.1.1-7 Item Description

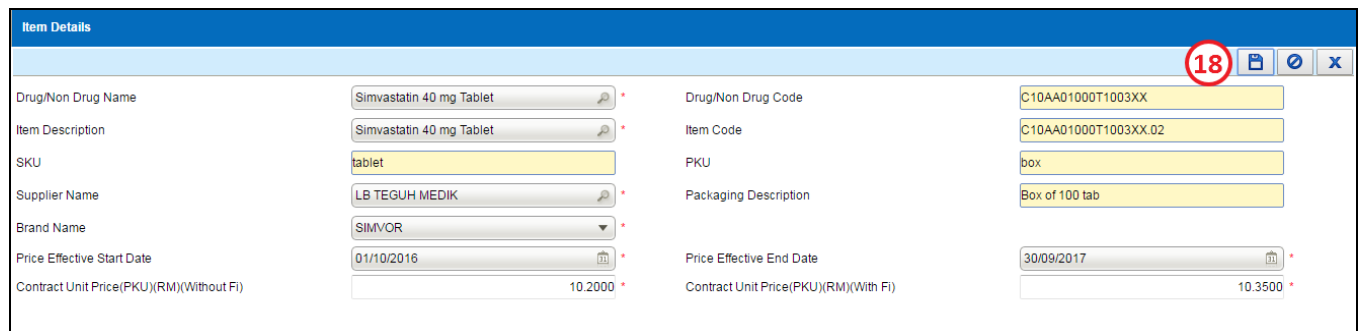

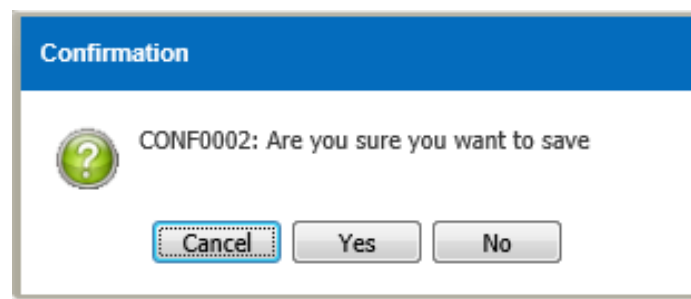
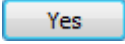


Figure 3.1.1-10 Save Record Alert Message

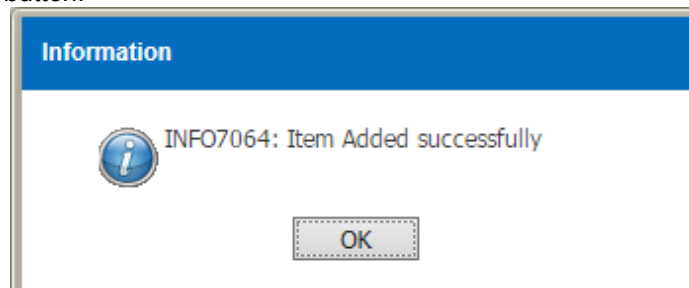
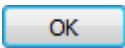
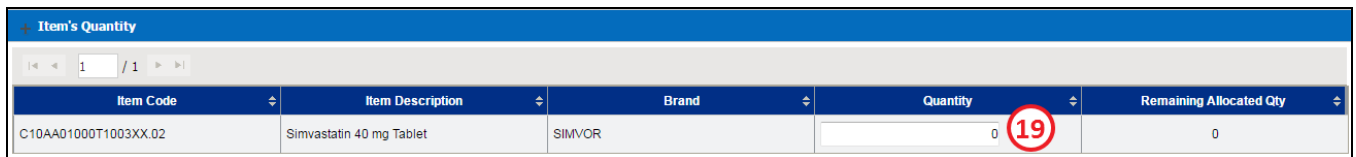


Figure 3.1.1-11 Item Added successfully Alert Message

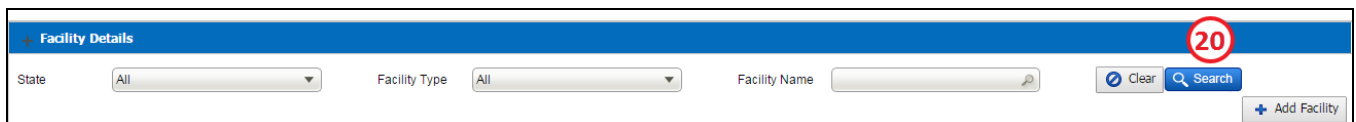


Figure 3.1.1-13 Facility Details

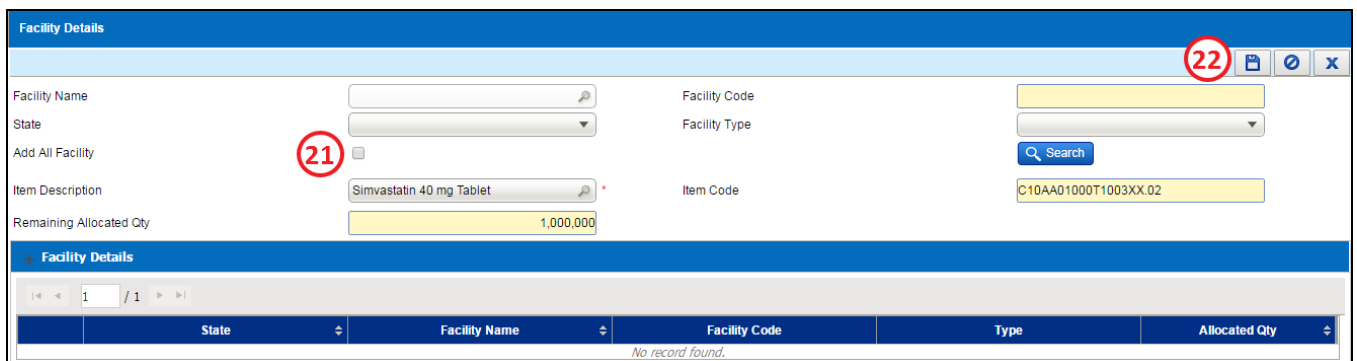


Figure 3.1.1-14 Facility Details

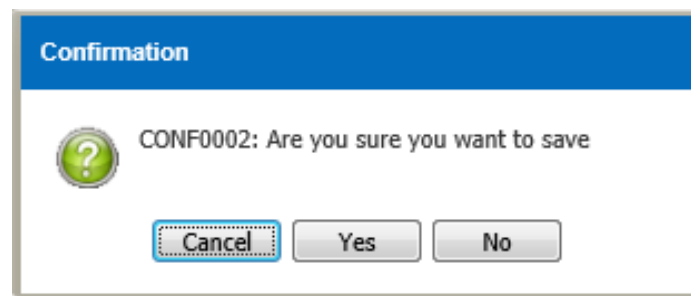
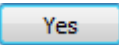


Figure 3.1.1-15 Confirmation Message

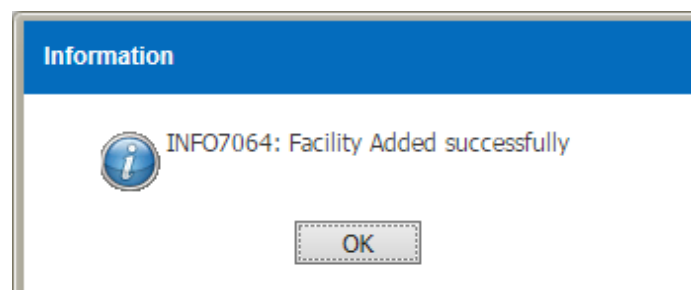
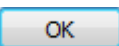
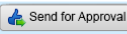
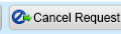


Figure 3.1.1-16 Information Message

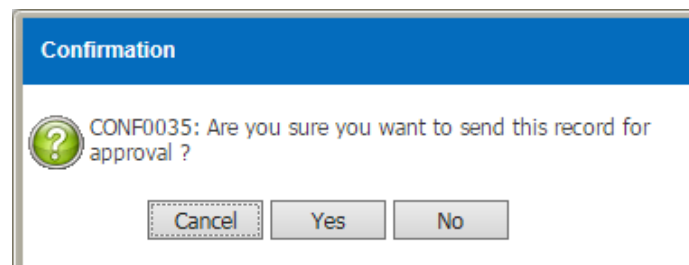
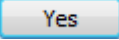


Figure 3.1.2-18 Confirmation Message

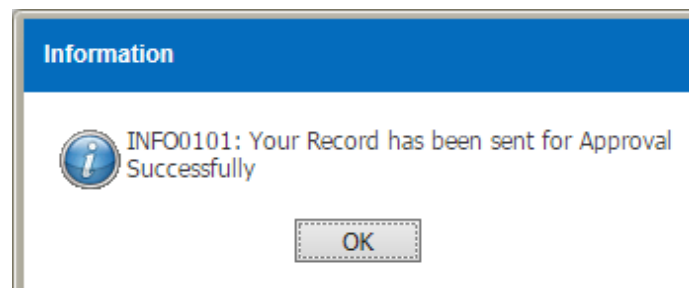
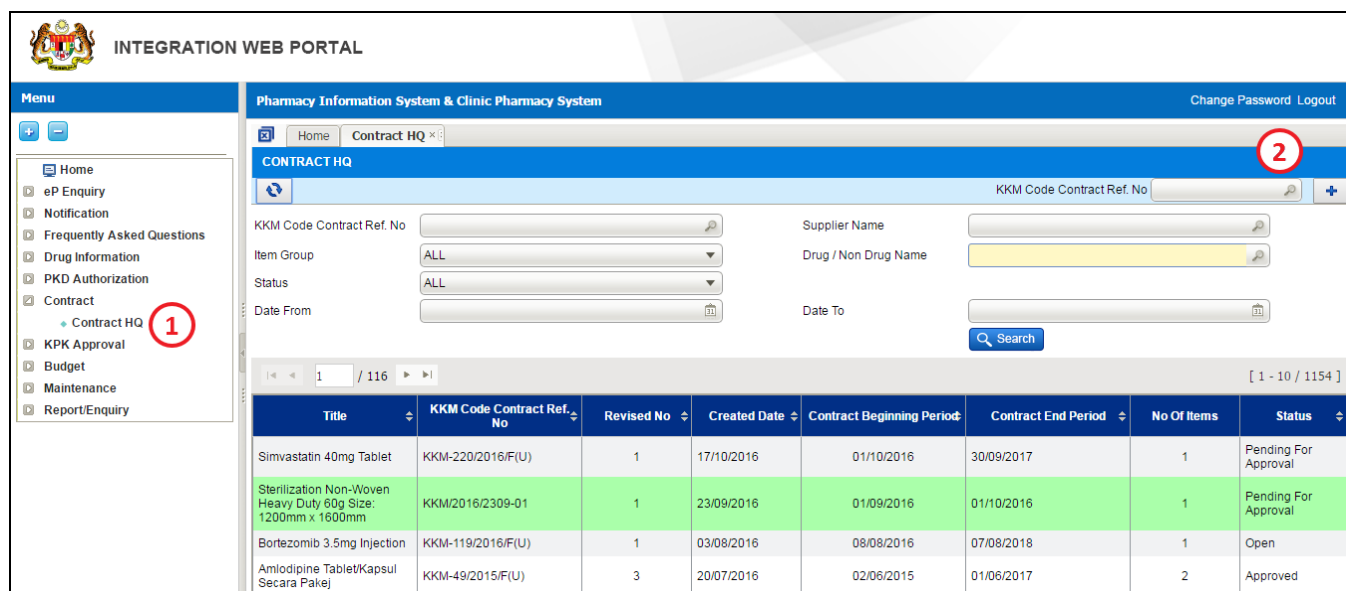


Figure 3.1.2-19 Information Message

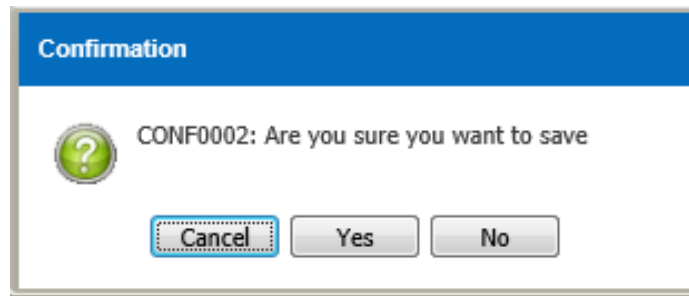
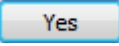


Figure 3.1.2-9 Confirmation Message

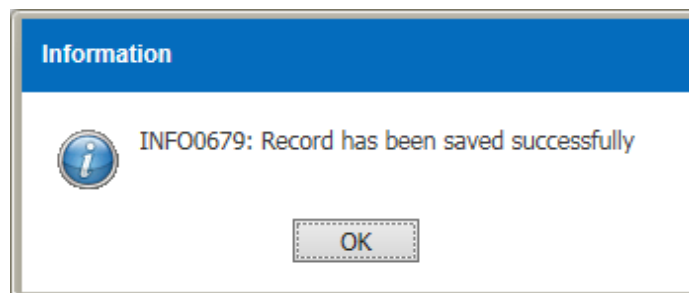
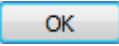


Figure 3.1.2-10 Information Message
